# What is Court Cases Online?

**The new Court Cases Online System provides general case information and all docket entries that can be accessed remotely via the Internet.**

**The following cases are available through this new Court Cases Online System:**

- All open Civil Division cases (including civil actions, landlord-tenant and small claims) as well as closed cases dating back to 2000
- All Criminal Division cases
- All Large and Small Estate Probate Division cases
- All Tax Division cases
- All Criminal Domestic Violence cases

# What Information Is Displayed?

- Summary – Case number, case type, status (open, closed, etc) and date the case was filed.
- Parties – Primary individuals in the case, and their role in the case (e.g. plaintiff (person filing the case), defendant (the person against whom the case is brought)). The information is limited to the party's name and their attorney, if they are represented by one.
- Case Schedule – Next hearing scheduled for a case.
- Docket – A chronological listing of all of the officially recorded entries for a case.
- Financial – Any court fees associated with a case and payment of the fees.

# What Information is excluded?

- Images (i.e., scanned copies of the filings in the case)
- Addresses
- Social Security Numbers
- Phone Numbers
- Date of Birth
- Sealed cases or documents which have been sealed




