

**\*\*IMPORTANT INFORMATION\*\***

If you are unable to pay for your own attorney, you may be eligible for court appointed counsel. You may be asked to provide proof of income and residence information.

**No New Charges Filed from Arrest (formerly No Papered):**

The government may choose to decline to file charges against you as a result of your arrest. You may check the Court's website at [www.dccourts.gov](http://www.dccourts.gov) one day prior to your scheduled appearance to determine whether or not charges have been filed. Please have your citation release form with you. It contains information that you may need in order to identify whether or not your charge was papered. If you do not have access to the internet, you may call the Court's Criminal Division Customer Service line at 202/879-1373.

**NOTICE REGARDING CERTAIN TRAFFIC OFFENSES:**

**When charged with No Permit, OAS, or OAR, bring:**

- A valid permit (or learner's permit) from the District of Columbia Department of Motor Vehicles (DMV) or a valid out-of-state permit; and
- A 15-year driving record; and if you were suspended or revoked, documentation from the District of Columbia DMV or from your home state DMV, stating that you have:
  - Corrected any problems, such as paying outstanding tickets, that led to your suspension or revocation,
  - Paid any reinstatement fee, and
  - You must bring in a certified letter/document indicating you are in good standing and you have been reinstated.
